However, with the express authorization of the Lessor and payment of the Cross Border supplement, circulation may be permitted in the following European Union states: Austria, Croatia, France (excluding Corsica and French overseas territories), Germany, Slovenia, Switzerland, Vatican City, Republic of San Marino, Principality of Monaco. In the event of circulation in states not permitted and/or exit of the vehicle from the Territory of the Italian State without authorization, the relevant penalty of €500.00 will be charged and any conventional limitation of liability purchased will cease to be effective in the event of an accident/theft.
